FOR THE OVERALL SUPERVISION OF SUBORDINATE SECURITY ASSIGNED TO THE
HOUSING UNITS, AND FOR THE SUPERVISION, CUSTODY AND CONTROL OF ALL
INMATES ASSIGNED TO THE HOUSING UNITS. MAKES ROUTINE INSPECTIONS OF
THE LIVING AREAS FOR COMPLIANCE WITH SECURITY, SAFETY AND SANITATION
STANDARDS. CONDUCTS INVESTIGATIONS OF ALLEGED MISCONDUCT ON THE PART
OF INMATES AND SECURITY PERSONNEL ASSIGNED TO THE AREA OF RESPONSIBI-
LITY. ASSISTS IN CONDUCTING FORMAL AND INFORMAL COUNTS. SUPERVISES
THE JOB PERFORMANCE, CONDUCT AND APPEARANCE OF ASSIGNED SECURITY
PERSONNEL AND PREPARES EMPLOYEE EVALUATIONS. COUNSELS, RECOMMENDS
