ESTABLISHES ON-CALL PROCEDURES TO RESPOND TO EMERGENCY PLUMBING MAINTENANCE AND REPAIR CALLS AND ENSURES THE WORK IS PROMPTLY AND PROPERLY PERFORMED. SUPERVISES THE OPERATION AND MAINTENANCE OF PLUMBING FACILITIES SEWAGE DISPOSAL EQUIPMENT TO ENSURE COMPLIANCE WITH STANDARDS PRESCRIBED BY THE SCDHEC. DETERMINES REQUIREMENTS FOR PLUMBING SUPPLIES AND EQUIPMENT AND PREPARES JUSTIFICATION FOR AND REQUISITIONS ALL SUPPLIES.
