# Introduction and Report Summary

The PREA Coordinator's office, under the Office of Legal and Compliance, is pleased to provide this annual report of PREA activities and implementation efforts for 2020.

PREA Standard §115.88 requires SCDC to review its data collected and aggregated pursuant to Standard §115.87 in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices, and training by:

- 1. Identifying problem areas;
- 2. Taking corrective action on an ongoing basis; and
- 3. Preparing an annual report of its findings and corrective actions for each facility, as well as the Agency as a whole.

The SCDC PREA Coordinator submits the following information for your review and consideration:

In calendar year 2020, SCDC received 379 reported allegations of sexual abuse/sexual harassment. SCDC Office of Investigations and Intelligence investigated 30% of the allegations of sexual abuse/sexual harassment for criminal intent. 70% of the allegations were investigated by institutional investigators. 22% of reports were allegations of inmate-on-inmate abuse, and 23% were allegations of staff-on-inmate abuse. Of the 379 allegations, 6% of the allegations were substantiated, 40% were unsubstantiated, 38% were unfounded, and 16% of the cases are ongoing.

In 2020, nine (9) SCDC institutions were audited for compliance with the National PREA Standards by PREA Auditors certified by the United States Department of Justice.

Training on the National PREA Standards and SCDC Policy GA-06.11 was conducted at each Agency On-boarding, Orientation, and Basic Training class provided in 2020, in addition to the annual mandatory Legal Update provided by the Agency's Division of Training and Staff Development.

As with previous years, SCDC continued our Agreements with multiple Rape Crisis Centers (RCC) to provide emotional support services to incarcerated survivors of sexual abuse. The ten (10) RCCs provide hundreds of hours of support to survivors inside SCDC, including individual face-to-face contacts, group sessions, written correspondence, and phone calls through a toll-free hotline. Because of COVID-19, face-to-face and mail contact was not available to the advocates for the majority of 2020. Therefore, other methods were used by the RCCs to provide support to survivors, including video conferencing and distribution of pre-recorded trauma trainings.

In 2020, SCDC continued working with the grant programs begun in 2019. Grant funding continues to assist SCDC with developing programs, purchasing equipment, and enhancing the Agency's compliance with the National PREA Standards.

#### Areas of Concern:

The South Carolina Department of Corrections continues to adjust its policies, procedures, and practices as it measures, through auditing, compliance with the National PREA Standards. Through internal reviews and audits conducted by certified PREA Auditors, SCDC has made continuous improvements to its correctional practices. Some areas of concern are the risk of sexual victimization and abusiveness assessments and reassessments, and inmate education.

Although greatly affected by COVID-19, the institutions audited in 2020 noted the need to ensure initial and reassessments for risk of sexual abuse were conducted and conducted within the timeframes prescribed by Standard §115.41. Additionally, institutions also were instructed to ensure inmates are provided training on the Agency's and institutional policies, rules, and guidelines surrounding reporting of allegations of sexual abuse and sexual harassment in a timeline prescribed.

These concerns were addressed during the corrective action periods of multiple audits of institutions and does not extend across the Agency.

On December 2020, the SCDC inmate population was lower than it was on December 31, 2019, which had an inmate population of 18,059 inmates. On December 31, 2018, the inmate population was 18,505.

Based on the inmate population at the end of 2020, of the 379 allegations of sexual abuse/sexual harassment reported in 2020, the data received represented 2.4% of the inmate population, with 0.13% (21) of the allegations being substantiated.

Of the 379 reported cases of sexual abuse/sexual harassment in 2020, 21 of these cases were found to be substantiated, 6 of which were substantiated incident(s) of inmate-on-inmate sexual abuse; 4 were inmate-on-inmate sexual harassment; 10 were staff sexual misconduct; and 1 was a staff-on-inmate sexual harassment incident. The majority of incidents were inmate-on-inmate sexual harassment allegations (112); followed by staff-on-inmate sexual harassment (95), staff sexual misconduct (89), and lastly, inmate-on-inmate sexual abuse (83).

In comparison with the 2018 and 2019 data, as presented in the spreadsheet, there was an increase in allegations by 19% (50) from 2018 to 2019, and an increase by 43% (114) allegations from 2019 to 2020. While allegations of inmate-on-inmate sexual harassment increased since 2018, this same data reveals that the communications plan is still working and that offenders continue to feel safe to report. Staff sexual misconduct cases have increased over the last year, as well as staff sexual harassment cases; however, the number of total substantiated cases has remained low. There were 10 substantiated cases of staff-on-inmate sexual abuse in 2020.

# Analysis

#### **Allendale Correctional Institution**

In 2020, Allendale Correctional Institution housed approximately 857 Inmates. Allendale Correctional Institution reported 13 allegations of sexual abuse/sexual harassment. Of those 13 allegations, 4 allegations were sexual abuse, and 9 were sexual harassment. There were 9 allegations against staff members.

Of the 13 investigations, 1 was substantiated, 1 was unsubstantiated; 4 were unfounded, and 7 investigations are ongoing.

Allendale Correctional Institution was audited for compliance with the National PREA Standards in 2020 and was found to have met or exceeded all Standards and provisions.

#### **Broad River Correctional Institution**

In 2020, Broad River Correctional Institution housed approximately 1,231 Inmates. Broad River Correctional Institution reported 51 allegations of sexual abuse/sexual harassment. Of those 51 allegations, 21 allegations were sexual abuse and 30 were sexual harassment. There were 26 allegations against staff members.

Of the 51 investigations, 2 were substantiated, 15 were unsubstantiated; 34 were unfounded, and no investigations are ongoing.

In 2020, Camille Griffin Graham Correctional Institution housed approximately 949 Inmates. Camille Griffin Graham Correctional Institution reported 30 allegations of sexual abuse/sexual harassment. Of those 30 allegations, there were 14 allegations of sexual abuse and 16 sexual harassment. There were 15 allegations against staff members.

Of the 30 investigations, 5 were substantiated, 10 were unsubstantiated, 7 were unfounded, and 8 investigations are ongoing.

McCormick Correctional Institution was audited for compliance with the National PREA Standards in 2020. McCormick C.I met 42 of the 45 audited Standards and needed to make additional corrections on Standards §115.33, §115.41, and §115.81. These corrections are being addressed by the institution.




# Allegation Breakdown

# **Corrective Actions**

To ensure SCDC continues its path to full compliance with the Federal PREA Standards, the Office of Legal and Compliance and PREA staff, in coordination with institutional PREA Compliance Managers, have implemented several corrective actions to address recommendations noted in the nine (9) PREA interim audit reports.

- 1. Screening for Risk of Sexual Victimization and Abusiveness: As prescribed in multiple SCDC policies and procedures, screening for risk of sexual victimization and abusiveness is required within the first 72 hours of an offender's arrival into an institution, and a reassessment is conducted within the first 30 days. This required timeframe has been difficult to achieve due to the effects of COVID on staffing in the institutions. To correct, the institutions have recruited additional staff from multiple disciplines to assist.
- 2. **Inmate Education**: As mentioned in the previous corrective action, SCDC policies and procedures prescribe a timeframe and description of what will be provided to offenders upon arrival. This requirement was affected by COVID in 2020. Institutions were instructed to ensure that all educational and training requirements for offenders are met within the timeframes prescribed.
- 3. **Video Monitoring:** SCDC Division of Security has implemented a plan created to increase and improve video monitoring throughout the Agency for the protection of offenders and staff. In 2020, several institutions were provided additional cameras and monitoring systems to increase visibility for staff. Due to the consequences of COVID, the plan was slowed and will be continued.
- 4. **Medical and Mental Health Screenings:** As required by multiple SCDC policies, all inmates who inform staff of previous incidents of sexual abuse are offered assistance by medical and/or mental health staff. To improve documentation of this offering, SCDC has included a screening alert for all inmates who indicate previous encounters with sexual abuse which is sent to applicable medical and mental health practitioners.
- 5. **Documentation:** Although several new forms were created to ensure documentation of required procedures, some forms were not being completed or were being completed incorrectly, causing corrective actions to be implemented. To improve the effectiveness of these forms, additional training will be provided to applicable staff members to ensure documentation is completed correctly.
- 6. **Physical Plant:** Due to the age of some of the Agency's institutions, it was noted that there is a need for additional physical plant improvements. PREA Staff are working with Facilities Maintenance to address concerns provided by PREA auditors.

7. Training: SCDC's Division of Staff Training and Development provides PREA training to all employees during Agency on-boarding, orientation, basic training, and annually as a required training for all staff. Although staff receive several trainings, several have had difficulty expressing knowledge of PREA during audits. To address this concern, the institutional PREA Compliance Managers (PCMs) have implemented intermediate trainings during briefings, routine announcements over loudspeakers, and monthly PREA updates. Additionally, the Agency's Multidisciplinary Management and Treatment Team (MMTT) has created a training that will be provided to all staff to further communicate and highlight some requirements of the PREA Standards.



# **Notable Successes**

Despite the constraints imposed upon the Agency and the State by COVID-19, SCDC was able to make observable strides in its efforts to achieve and maintain compliance with the Prison Rape Elimination Act of 2003. In 2020, SCDC had nine institutions audited for compliance with the National PREA Standards, for which 6 were found fully compliant, 1 needs minimal corrective action due to the effects of COVID-19 on administrative staffing, and 2 are awaiting final reports.

As an outcome of the COVID-19 pandemic, visitation from outside vendors, visitors, and contractors was suspended to mitigate the possible spread of the virus. This caused a suspension of face-to-face visits with advocates from the local rape crisis centers. To assist our inmate survivors, many of our local rape crisis centers were able to hold sessions with our inmates virtually through telehealth applications and some produced videos to teach survivors ways to cope and work with trauma related stress. These videos were shared through the inmate tablets and kiosks systems with all inmates at each institution.

Additionally, SCDC partnered with Just Detention International (JDI) in creation of the #PrisonersToo project. The project provides an outlet to female survivors of sexual abuse and domestic violence and allows incarcerated women a voice in the #MeToo movement. With assistance from a contracted artist, female inmates at Leath and Camille Griffin Graham Correctional Institutions completed Phase one of the project, completing an art project. The project consisted of up to 16 inmates at



both institutions painting individual panels to express their individual expressions of their trauma from sexual abuse. To complete the project, executive staff from Leath and Camille painted a few panels in solidarity with the women. When completed, the 16 individual panels collectively made a butterfly. The butterfly mural expressed the change in growth from being a caterpillar going into a cocoon and coming out a beautiful butterfly.

As a part of the project, the artist and participants were given an opportunity to express how the project affected them and what they hope will be expressed to others through their art. SCDC intends to continue working with JDI as the project progresses through its subsequent phases.

PREA Audit Cycle 3 began on August 20, 2019 and runs through August 19, 2022. To meet compliance, SCDC will audit seven correctional facilities each cycle year as prescribed by Standard 115.401(b).

#### $\$ 115.401 Frequency and scope of audits.

- (a) During the three-year period starting on August 20, 2013, and during each three-year period thereafter, the agency shall ensure that each facility operated by the agency, or by a private organization on behalf of the agency, is audited at least once.
- (b) During each one-year period starting on August 20, 2013, the agency shall ensure that at least one-third of each facility type operated by the agency, or by a private organization on behalf of the agency, is audited.
- (c) The Department of Justice may send a recommendation to an agency for an expedited audit if the Department has reason to believe that a particular facility may be experiencing problems relating to sexual abuse. The recommendation may also include referrals to resources that may assist the agency with PREA-related issues.
- (d) The Department of Justice shall develop and issue an audit instrument that will provide guidance on the conduct of and contents of the audit.
- (e) The agency shall bear the burden of demonstrating compliance with the standards.
- (f) The auditor shall review all relevant agency-wide policies, procedures, reports, internal and external audits, and accreditations for each facility type.
- (g) The audits shall review, at a minimum, a sampling of relevant documents and other records and information for the most recent one-year period.
- (h) The auditor shall have access to, and shall observe, all areas of the audited facilities.
- (I) The auditor shall be permitted to request and receive copies of any relevant documents (including electronically stored information).
- (j) The auditor shall retain and preserve all documentation (including, e.g., video tapes and interview notes) relied upon in making audit determinations. Such documentation shall be provided to the Department of Justice upon request.
- (k) The auditor shall interview a representative sample of inmates, residents, and detainees, and of staff, supervisors, and administrators.
- (1) The auditor shall review a sampling of any available videotapes and other electronically available data (e.g., Watch tour) that may be relevant to the provisions being audited. (m) The auditor shall be permitted to conduct private interviews with inmates, residents, and detainees.
- (n) Inmates, residents, and detainees shall be permitted to send confidential information or correspondence to the auditor in the same manner as if they were communicating with legal counsel.
- (o) Auditors shall attempt to communicate with community-based or victim advocates who may have insight into relevant conditions in the facility.

# **Definitions**

PREA standard definitions are provided in 28 CFR §115.5 and 28 CFR §115.6, which include the following:

**Sexual abuse of an offender by another offender** – Sexual acts, sexual contact or any other intentional touching, either directly, through the clothing or with an object, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation, in which the victim does not consent, is coerced by overt or implied threats of violence, or is unable to consent or refuse.

**Sexual abuse of an offender by a staff member** – Sexual acts, sexual contact or any other intentional contact, either directly, through the clothing or with an object, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, any attempt, threat, or request by a staff member or service provider to engage in these activities, any display by a staff member or service provider of his or her uncovered genitalia, buttocks, or breast in the presence of an offender, or voyeurism by a staff member or service provider, when these acts are unrelated to official duties or where the staff member or service provider has the intent to abuse, arouse, or gratify sexual desire.

**Sexual Harassment** – Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one offender directed toward another or repeated verbal comments or gestures of a sexual nature to an offender by a staff member or service provider.

**Sexual Misconduct** – Includes sexual abuse of an offender by another offender, sexual abuse of an offender by a staff member or service provider, sexual harassment, and voyeurism.

**Substantiated** – An allegation that was investigated and determined to have occurred.

**Unfounded** – An allegation that was investigated and determined not to have occurred.

**Unsubstantiated** – An allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether the event occurred.

**Voyeurism** – An invasion of privacy of an offender by a staff member or service provider for reasons unrelated to official duties.
